We hereby apply for admission for the **Real.Life.Music Camp**. The tuition fee (\$450) fully includes the camp registration, all programs of instruction, all lessons, meals (1 per day) & supervision. The tuition does not include optional medical insurance, musical equipment, musical equipment insurance or transportation to and from camp. In consideration of the camper's enrollment and the payment of the appropriate fees, Mr. Smalls Funhouse, Inc. (the recording studio) agrees to reserve a place and to hire instructors, counselors and staff. The camp's planning, hiring, promotion and expenses are directly determined by the number of enrollments. The seasonal nature of summer camp programming precludes any tuition rebate/ reduction/ allowance for camper's late arrival/ early withdrawal / non-arrival/ dismissal for cause after July 11, 2017.

If it is necessary to obtain off-grounds medical/ surgical/ dental services for the participant, such expenses shall be paid by the parent. Authority is granted without limitation to the studio/ assigns in all medical matters to hospitalize/treat/ order injections/ anesthesia/ surgery for the participant. The staff will attempt to contact parents during a medical emergency. The parent is responsible for all pre-existing medical conditions, medical/surgical/ hospital/pharmaceutical/allergy expenses, and for providing adequate quantities of medications and allergy serums to the camp in pharmacy containers and with doctor's written instructions.

Mr. Smalls Funhouse, Inc. is hereby appointed *Loco-Parentis*. Participants may use electrical & musical equipment and other hazardous equipment with supervision, may participate in any activity/trip including special workshops & events organized by the studio staff on or off the studio-grounds and may travel, when deemed necessary by the studio, via private or studio vehicles. Mr. Smalls Funhouse, Inc. & Creative.Life.Support, Inc. are not responsible for damage/ loss/ safety of musical instruments/clothing/ personal equipment used during the participant's stay.

The participant and his or her parents agree to abide by the camp/studio rules and regulations for the health/safety/ welfare of the participants and the camp community. Smoking, possession of or use of tobacco/ narcotics/ liquor or other intoxicant non-prescription drug on or off the studio grounds is expressly forbidden. Participant may not leave studio/camp grounds without the permission of the camp director(s). Violation of these rules or other reasonable regulations will result in dismissal from the camp without tuition rebate. In the event of dismissal it is the responsibility of the parents to transport the camper home in a timely manor. The studio reserves the right to dismiss any participant whose conduct is unsatisfactory or inimical to the studio's best interest without tuition rebate.

The Real.Life.Music Camp program may include public performances and permission is hereby given for the participant to take part in such performances on/ off studio-grounds without compensation. Real.Life.Music Camp may use photographs/ statements/ articles/ names/ music/ art/ films/ videotapes/ of/ by the participant in promoting camp/camp related activities/ publication/ advertising and exhibitions.

Enclosed with agreement is \$450.



Any outstanding balance due precludes admission to the camp. In the event of any dispute that may arise out of this agreement or otherwise between the parties to which the studio or its agents is a party shall be in the town of Millvale, PA.

The parent/ guardian represents that he/ she has full authority to enroll in the camp/ to authorize participation of activities/medical care and to contract as foresaid. This agreement constitutes the full understanding of the parties and cannot be modified except in writing signed by the parties.
